

JT's RV Accessories

90 day Limited Warranty

In addition to the factory 90 day warranty, an extension of one (1) year of coverage may be purchased for \$25.00. Please see enclosed order form.

JT's RV Accessories, warranty obligations for this hardware product are limited to the terms set forth below:

JT's RV Accessories, as defined below, warrants this hardware product against defects in materials and workmanship under normal use for a period of ninety (90) days from the date of retail purchase by the original end-user purchaser ("Warranty Period"). If a hardware defect arises and a valid claim is received by JT's RV Accessories within the Warranty Period, at its option and to the extent permitted by law, JT's RV Accessories will either (1) repair the product at no charge, using new or refurbished replacement parts, (2) exchange the product with a product that is new or which has been manufactured from new or serviceable used parts and is at least functionally equivalent to the original product, or (3) refund the purchase price of the product. JT's RV Accessories may request that you replace defective parts with new or refurbished user-installable parts that JT's RV Accessories provides in fulfillment of its warranty obligation. A replacement product or part, including a user-installable part that has been installed in accordance with instructions provided by JT's RV Accessories, assumes the remaining warranty of the original product or thirty (30) days from the date of replacement or repair, whichever provides longer coverage for you. When a product or part is exchanged, any replacement item becomes your property and the replaced item becomes JT's RV Accessories property. Parts provided by JT's RV Accessories in fulfillment of its warranty obligation must be used in products for which warranty service is claimed. When a refund is given, the product for which the refund is provided must be returned to JT's RV Accessories and becomes the property of JT's RV Accessories.

EXCLUSIONS AND LIMITATIONS

This Limited Warranty applies only to the hardware product manufactured by or for JT's RV Accessories that can be identified by the "JT's RV Accessories" trademark, trade name, or logo affixed to it. The Limited Warranty does not apply to any non-JT's RV Accessories hardware product or any software, even if packaged or sold with the JT's RV Accessories hardware. Manufacturers, suppliers, or publishers, other than JT's RV Accessories, may provide their own warranties to the end user purchaser, but JT's RV Accessories, in so far as permitted by law, provides their products "as is".

With respect to its use; JT's RV Accessories does not warrant that the operation of the product will be uninterrupted or error-free. JT's RV Accessories is not responsible for damage arising from failure to follow instructions relating to the product's use. This warranty does not apply: (a) to damage caused by use with non-JT's RV Accessories products; (b) to damage caused by accident, abuse, misuse, flood, fire, earthquake or other external causes; (c) to damage caused by operating the product outside the permitted or intended uses described by JT's RV Accessories; (d) to damage caused by service (including upgrades and expansions) performed by anyone who is not a representative of JT's RV Accessories or an JT's RV Accessories Authorized Service Provider ("AASP"); (e) to a product or part that has been modified to alter functionality or capability without the written permission of JT's RV Accessories.

TO THE EXTENT PERMITTED BY LAW, THIS WARRANTY AND THE REMEDIES SET FORTH ABOVE ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, REMEDIES AND CONDITIONS, WHETHER ORAL OR WRITTEN, STATUTORY, EXPRESS OR IMPLIED. AS PERMITTED BY APPLICABLE LAW, JT'S RV ACCESSORIES SPECIFICALLY DISCLAIMS ANY AND ALL STATUTORY OR IMPLIED WARRANTIES, INCLUDING, WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND WARRANTIES AGAINST HIDDEN OR LATENT DEFECTS. IF JT'S RV ACCESSORIES CANNOT LAWFULLY DISCLAIM STATUTORY OR IMPLIED WARRANTIES THEN TO THE EXTENT PERMITTED BY LAW, ALL SUCH WARRANTIES SHALL BE LIMITED IN DURATION TO THE DURATION OF THE EXPRESS WARRANTY AND TO THE REPAIR OR REPLACEMENT SERVICE AS DETERMINED BY JT'S RV ACCESSORIES IN ITS SOLE DISCRETION.

No JT's RV Accessories reseller, agent, or employee is authorized to make any modification, extension, or addition to this warranty. If any term is held to be illegal or unenforceable, the legality or enforceability of the remaining terms shall not be affected or impaired.

JT's RV Accessories may provide warranty service (i) at JT's RV Accessories corporate offices or AASP location, where service is performed at the location, or the JT's RV Accessories may send the product to an JT's RV Accessories repair service location for service, (ii) by sending you prepaid way bills (and if you no longer have the original packaging, JT's RV Accessories may send you packaging material) to enable you to ship the product to JT's RV Accessories repair service location for service, or (iii) by sending you new or refurbished customer installable replacement product or parts to enable you to service or exchange your own product ("DIY Service"). Upon receipt of the replacement product or part, the original product or part becomes the property of JT's RV Accessories and you agree to follow instructions, including, if required, arranging the return of original product or part to JT's RV Accessories in a timely manner. When providing DIY Service requiring the return of the original product or part, JT's RV Accessories may require a credit card authorization as security for the retail price of the replacement product or part and applicable shipping costs. If you follow instructions, JT's RV Accessories will cancel the credit card authorization, so you will not be charged for the product or part and shipping costs. If you fail to return the replaced product or part as instructed, JT's RV Accessories will charge the credit card for the authorized amount.
